Purpose of Report

To update the Planning Committee on the status of recent applications called by the CNPA.

Background

- I. The Planning Committee are aware that the determination of planning applications can be delayed by a lack of relevant information being provided by applicants. This can lead to delays as proposals then require to be re-consulted upon or re-advertised in public.
- 2. The CNPA's use of processing agreements provides a way managing these delays through the agreement of applicant and CNPA. However, over the last year in particular, the CNPA's experience has been that applications have been made with enough information to be a valid planning application, but not with enough to be brought to a Planning Committee with a recommendation of approval. There have been a number of applications that could have been determined significantly faster and more efficiently for both CNPA and applicant, had they provided the necessary and accurate information early in the process. Applicants are often reluctant to withdraw an application that cannot be approved, but clearly do not want their application to be refused.
- 3. As part of the planning services' work to reduce the likelihood of such delays, we will be strengthening the terms of our processing agreements to make it explicit that if applicants do not provide the necessary information within the agreed and reasonable timescales set out in the processing agreement, officers will take planning applications to Planning Committee with the information that has been provided. There is a strong likelihood that the recommendation in such cases would be to refuse the application.
- 4. To give the Planning Committee some background context to this, we will produce a report at each Planning Committee that summarises the current planning applications being determined by the CNPA and highlights any cases where significant additional information is required. In many cases, additional information will be sought to overcome potential issues for a development proposal and make it acceptable.

5. There is always a judgement for officers to make about whether the information is essential and how close the application is to determination. However, in some cases, months can pass without fundamental information being provided and in those circumstances, it would be better for CNPA, applicant and the public for the case to either be withdrawn or to be decided on the basis of the information that has been submitted.

Next Steps

6. Appendix I summarises all the applications called in by the CNPA that have yet to be taken to a Planning Committee meeting. At future Planning Committee meetings any cases with significant information gaps that cannot be resolved through normal processing agreement timescales will be highlighted. If there is a need to bring an application to determination with partial information, the relevant Planning Committee report will set out the processing agreement or other reasonable timescales that had been given to allow the information to be provided.
