#### 5. Etape Royale Cycle Event

David Fox-Pitt gave an over view of the proposed Etape Royale Cycle Event, scheduled to take place on Sunday 27<sup>th</sup> September 2015. The 100 mile closed circular route will run from Braemar. Further information can be obtained at www.etaperoyale.com.

#### 6. Finance

The Treasurer confirmed that the Annual Accounts for year ending 28 Feb 2015 had been examined and subsequently approved at the Directors' meeting, and would be presented to members for the AGM. She said that she had made some changes from previous Accounts which would now show a zero balance once the AOCC costs had been reimbursed by grants. This was approved by the Examiner. The changes relate to Insurance and Accruals. Previously the AOCC's insurance payment was split over two years, but now show the total amount as a cost in the year as it is reimbursed in the year. Previously there was no accrual for costs incurred in the year which would be reimbursed by Grants.

Accounting year: It was agreed to make no change despite problems in the past because the AOCC's accounting year differed from the CNPA's (CNPA is 31st March, AOCC is 28th February).

Future funding: The CNPA granted up to £4,000 for the year ending 28 Feb 2015. It is not known exactly how much the CNPA will offer in grant funding for the new financial year.
