

### **Review of Scottish Planning System**

In September 2015, the Scottish Government appointed an independent panel to undertake a review of the Scottish planning system. The report and recommendations of the review, 'Empowering Planning to deliver great places', were published on 31 May 2016.

Many changes to the planning system are recommended, including a review of the planning arrangements in the Cairngorms National Park. This proposal is in line with evidence we presented to the Panel and has been welcomed

by CNPA. The Scottish Ministers will now consider the report and recommendations.

### **LDP Monitoring Report**

The first Monitoring Report for the Cairngorms Local Development Plan 2015 has been prepared to give an overview of how the plan has been used in its first year of implementation. The CNPA called in 7% of application made in the National Park during the year, compared to 15% over the previous five years of the Cairngorms Local Plan.

Between March 2015 and March 2016, 361 planning applications were determined within the National Park, 27 by the CNPA. 97% of all the applications were approved and 3% refused.

### Staff Changes in the CNPA Planning Team

The planning team is now fully staffed following a number of recent appointments:
