The Cairngorms National Park Local Development Plan (LDP) identifies sites for future development.

These include a number of sites which had planning permission at the time of plan preparation / adoption, including the Aviemore Highland Resort (AHR). AHR is a key site within Aviemore and has significant development potential.

Whilst part of the site has an extant planning permission for housing development, outline planning permission which was granted in 2011 for the wider site has now lapsed.
