We don't have a problem with this venture! An observation might be people in cars coming in and out of an establishment this size and location. Road access would have to be carefully thought through. I would imagine it would have to be a very attractive building, which is very unlikely when I look at other recent new builds in Aviemore.

I would like to suggest to the planning dept and the Park planners that a minimum of 35% of the exterior of building should show natural stone. I would also suggest that builders who wish to finish the exterior of buildings with harling should have to use natural stone. Other National Parks have set up building and other guide lines and I think that we should be urgently looked into building plans for our CNP.

Recently while I was visiting Sweden I had the opportunity to look at how they approach the problems of loe finding its way under roofs and looking at the Swedish brochures they have drainage profiles that will combat this problem.

I am disappointed that a draft letter has already been raised in support of this application. It would, in my view, be wise to canvass the opinion of members before presenting a document implying representation their views. Who decided this is a good idea?

I do not support this application nor do I believe that this will benefit the tourist sector in any way. Whilst there may be occasions, at peak times, when demand outstrips supply this is rare. There are many small accommodation providers who are forced to close or struggle to survive during the winter/shoulder months through lack of trade.

Your organisation should be aware of the number of accommodation providers who have gone out of business in recent years, how is providing more cheap accommodation going to help to provide a sustainable environment for those that remain.

The claim of increased employment and investment is always the easy argument in trying to justify developments, but never takes account of the negative impact. How many businesses will become unviable or staff lay-offs happen, should this unnecessary development go ahead.

I agree that tourism is the life-blood of this area, it already offers a wide and varied range of accommodation, perhaps we should ensure that existing providers can grow and invest before supporting potentially damaging developments.

I would appreciate acknowledgement of this email and confirmation that the real views of members will be represented.
