

Full Planning Permission
Erection of 3 Storey Building comprising of 12 No Apartments,
New Access and Associated Car Parking






- •Proposal for 12 apartments in 3-storey block
- •Site located in prominent position on green to south east of Four Seasons Hotel
- •A building in this position was originally part of masterplan application for AHR which the CNPA determined. This element of the masterplan was removed at the request of CNPA
- •Raises a number of issues with regard to landscape, building design, economic development and linkage to earlier application that CNPA dealt with.

RECOMMENDATION: CALL-IN Proposal is for a significant building fronting onto Grampian Road Aviemore. The proposal reflects one that the CNPA requested the removal of from the overall masterplan for the AHR site. The application raises issues with regard to landscape, building design and social and economic development. Consequently, it raises issues for the collective aims of the CNP.

Full Planning Permission Extension to House




- Proposal for side extension to existing house to provide additional bedroom



Erection of Replacement Extension




- Proposal for rear extension to existing house on site of small extension to provide kitchen, additional bedroom

KEY POINTS


- •Application seeks conservation area consent for demolition of bungalow in centre of photograph

RECOMMENDED COMMENTS: Trees in vicinity to be protected, landscaping for site when building removed



Site for extension






