Second, we refer to page 40, paragraph 5.28. The late addition of the identity of two important sources of information on such a critical matter as housing demand, at this late stage in the consultation process, is not acceptable and we wish to register an objection, on the grounds that it leaves too little time for concerned parties in the Community to examine these information sources in order to assure themselves of the integrity of the decisions made by the CNPA with respect to housing matters. We strongly suspect that the concept of "Development solely for affordable housing" could offer a more cost effective route (in terms of the net unit cost of affordable homes) to satisfying the needs of Ballater people for affordable housing than that achievable under the current CNPA strategy, which involves paying large public subsidies to a developer to damage the environment of Ballater by building houses which the Community does not need or want. Further, we believe that, if the concept of "Development solely for affordable housing" were combined with the removal of Ballater area H1 from the housing land allocation, and efforts were made vigorously to pursue opportunities for intelligent "brown field" and infill developments, then the recommendation by the Prince's Foundation of 28 September 2007, that "social housing should not be clustered in groups of more than about 5 units to avoid creation of social divides" could be achieved more naturally than would be possible with mass development in area H1. It would also give the added benefit of resolving much of the public opposition regarding the housing proposals for Ballater, provided area H1 and the land beyond it is dedicated to amenity/recreational use in perpetuity.

Fourth, we refer to page 43, policy 21, 2nd paragraph. We object to the change of wording from: "Where public funding is available to help fund affordable housing, the overall affordable contribution of the development will be expected to be 40%, with any shortfall between the public subsidised element and 40% target to be made up by the developer"to:

"Where public funding is available to help provide affordable housing, between 25% and 40% of all units will be expected to be affordable".

This change appears to represent a significant relaxation in the terms offered to the developer, and an unacceptable increase in the burden on UK tax payers. But previously we envisaged that the 40% mark was guaranteed as the developer would fund these houses out of their own finances, because we suspect that it is most unlikely that there will be any public funding available. But the change to "Where public funding is

available to help provide affordable housing between 25% and 40% of all units will be expected to be affordable" is completely unacceptable as it puts no onus on the developer to supply affordable housing at all.

In summary we are shocked and horrified by the impact these changes will have on supplying what Ballater requires. It is our belief that they are so enormous to insist that the Cairngorms National park Local Plan be withdrawn. Having considered this, I am not satisfied that the objections (dated 27th September 2007) in respect of the first Modifications have been adequately addressed. These sought adjustments to the Proposals Map (Aviemore) and some explanatory text.

In so far as the Second Modifications indicate, I understand matters to be as follows:

H1 has been adjusted in part, but does not reflect the full extent of the deficiencies which were identified for the Park Authority's consideration.

C2 remains as was. The adjustment suggested to the Park Authority which would embrace C2 within the wider masterplan (ED3) is not addressed nor explained. As it stands, C2 is not consistent with the emerging masterplan. In similar vein, the parcel previously annotated OS1, south west of the Four Seasons Hotel, is not embraced as part of ED3, as suggested. Rather it is now annotated ENV and may be less favourable to the AHR interests for that. the suggested text changes to ED3 are not made.

In addition, land north and south of the AHR also suggested as being suitable for embracing within ED3 is neither addressed nor explained. The objections lodged on behalf of AHR are therefore sustained. In addition, the above change from OS to ENV potentially adversely affects the AHR interest and we therefore lodge objection to that second modification.

Your letter invites confirmation that the objection would be heard in a verbal session, as previous intimated. I confirm this and am content with an informal hearing rather than formal Inquiry.

Mr Aardenburgh objects to the wording change proposed in the Second Modifications to the Cairngorms National Park Deposit Local Plan on Page 72, Kingussie Proposals KG/H1 paragraph iii.

The land shown allocated in Figure 1 for residential development (site H1) on the extract from the Proposals map for Kingussie as modified by the Deposit Local Plan Second Modifications is allocated for this use in the current adopted local plan, the Badenoch and Strathspey Local Plan (adopted September 1997). The land area allocated is more extensive in the current local plan than as allocated in the Cairngorms National Park Deposit Local Plan though this still remains a significant development site at up to 300 residential units. Further land is allocated in the current local plan for employment uses and following the consultation process at an earlier stage in the development of the Cairngorms national Park Deposit Local Plan, part of this allocation was re-instated in the Cairngorms National Park Deposit Local Plan.

It is the clear intention in the current local plan that this significant development area is to be accessed from the A86 and this intention has been maintained throughout the development of the Cairngorms National Park Deposit Local Plan, which until the Second Modifications has consistently maintained clear wording to establish this access requirement. We fully support the view of the National Park Authority as expressed prior to the Second modifications. As site out in the Technical Note produced by Messers Fairhurst, transportation consultants, attached as appendix A, a development of this significance will require construction of an access road of local distributor standard. No additional accesses are proposed onto the A86, the existing access to properties including Kerrow Cottage being incorporated into the upgraded access, which as advised by Messers. Fairhurst is likely to incorporate a ghost island right-turn lane. Full consultation with Transport Scotland will be undertaken through the development appraisal process and a Transport Assessment will be undertaken to ensure development of this site does not create an unacceptable cumulative impact on the A86 or A9.

Discussions have been held with the National Park Authority and Highland Council Roads and Community Works Department on this issue. It is clear from these discussions and the analysis undertaken by Messers. Fairhurst that access to anything other than a small number of residential units or for the provision of emergency access cannot be made to the site via the existing local road network, due in part to the unsuitability of these roads, which are particularly narrow closer to the town centre. Such access would lead to a substantial deterioration in the amenity of the residents in the existing residential areas. It is important therefore that the main access to the site should be from the A86. Full consideration of these matters will be given in the 'masterplan' which will be developed for the site in conjunction with the National Park Authority.

In light of the above, the modification proposed to the wording on page 72, Kingussie Proposal KG/H1 paragraph iii in the Second Modifications to the Cairngorms National Park Deposit Local Plan, "Access to this site should be taken from the local road network" is not acceptable, not least because it is ambiguous but potentially because it is undeliverable. It is possible, when considering the nature of the A86 through the town of Kingussie to see it in reality as a 'local road' particularly when

examining its relationship to the A9 as a major trunk road. On this basis, the amended wording would seem innocuous. However, as the A86 retains trunk road status the only logical conclusion which can be drawn from the amended wording is that access cannot be taken from the A86. for the reasons already established, such a position is not sustainable as it is likely to render the development undeliverable. We therefore consider that the National Park Authority should revert to its previous clear and unambiguous position which will ensure that the development remains effective and important employment uses can be delivered to enhance the economic well-being of the town.
