Further to your letter of 23 July and subsequent letter advising change of submission date, please find enclosed further information regarding the above application.

Regarding the opportunity to address the Planning Committee, we would wish to attend the meeting, on date to be advised by the Committee.

As previously explained during our meeting with yourself and Mr Fergus Ewing on 9 September 2011, we had to make a very stressful decision to sell our home of 13+ years and move due to harassment from neighbours. We had approached the Park Authority in 2007 prior to putting our house on the market and asked the question would a wooden house be acceptable for construction in the Park and were assured that this would be the type of house totally acceptable.

We spent considerable time looking for suitable accommodation in Grantown and surrounding area to suit our needs both with regard to cost and location prior to going down the route of planning this eco home in line with CNPA Local Plan Policy 16 'Design Standards for Development'. We have chosen a Finnish build due to their Environmental commitment, their replanting policies which far outweigh any Scottish policy, the fact that European wood is slower growing and has less shrinkage that Scottish and the major factor that it costs a third less to buy Finnish than Scottish therefore not making such a hole in our finances.

Mrs Drummond has personally made a lot of commitment within the communities of both Grantown, Dulnain Bridge and Cromdale over the past 32 years serving as Dulnain Bridge Fete Secretary, Chairman of the Primary School PTA (6 years), Chairman of Cromdale Village Hall, Secretary of Cromdale & Advie Community Council, Dancing Covenor for 10 years to the Grantown Highland Games, Chairman of Octopus Parent and Children Swimming Club together with many other fund raising efforts connected to the Royal Air Force Grantown-on-Spey's Senior Citizen Lunches, Help for Heroes to mention a few.

We may now have to consider moving out of the 'Park' area to achieve our ambition of building this Eco home. Not only would this cause upheaval for our 14 year old Son, who has lived here all his life, the connection my four daughters and their families have with the area, also I doubt that we

would be able to remain in our current employment Mrs Drummond's with the Royal Air Force, which she has been in for nearly 31 years and Mr Drummond's LGV employment within the Whisky Industry since 1990.

Mr Andrew Falconer, the owner of the land and Mr Bill Cassells, who has provided us with a Deed of Servitude for the access and owners of the adjacent land are very supportive of our eco house application.

Please find attached the circumstances behind our Planning Application, as advised to do so, by Mr Fergus Ewing

We have spent a considerable amount of time (4 years) given thought to the environmental impact of the home we wish to build.

We propose to build a Finnish log home using laminated timber logs. We chose timber as it produces 85% less carbon in production to traditional bricks & mortar & it is difficult to think of a more environmentally friendly method of construction. The Company we plan to use have an excellent replanting programme where they replant 5 trees for every tree that is harvested & all waste wood is generated into other heating or building resources. The log homes have a negative carbon footprint when the average tree is offset against manufacturing, planing & transport.

We have looked at various types of insulating materials & aim to use a natural, sustainable & renewable insulating material in the form of sheep's wool. Heating will be via an economical & environmentally friendly Biomass Boiler system that will use wood pellets as fuel.

Our foul drainage will be processed through a Treatment plant, this breaks down any sewage & produces a very high quality of effluent suitable for discharging to an infiltration field drain. The treatment plant will have a sampling chamber installed so that samples can be taken to check the quality of effluent.

Mr Falconer who owns the adjacent field has agreed for us to position our treatment plant, sample chamber & soakaway out with our plot to ensure that it is situated 50 metres from our water supply.

We have had a full Aquatic survey of the plot carried out to ensure a private water supply sufficient for our needs. We also plan to install a recycling rain water system from the guttering so that the water can be re- used for gardening etc.

We are to have our main electricity supply underground so as not to disturb any impact on the land with poles, etc. Careful consideration has been given to the amount of lights throughout the house, and to electrical appliances.

We intend once the build is completed to plant natural trees and bushes to encourage birds and insects.

To enable us to build the above house we have:

In January 2011 contact was made with Mr McCracken of the Planning Department of Highland Council in Kingussie.

A request was made for Mr McCracken to visit the proposed building site with a view to establishing the viability of building there.

Mr McCracken refused on the basis that we would not be given permission to build there. This decision was made immediately and without any consultation or visit to the site.

In February 2011 we wrote to Mr Tait of the Cairngorm National Park asking his views of the proposed build. A reply was received from a Mr Grant quoting a paragraph from the Park Guide and again without any further information of the build we were advised that permission would not be granted.

Mrs Drummond attended a Building Consultation at Nethybridge which involved both the Highland Council, Cairngorm national park and members from various other agencies.

At this meeting both Mr McCracken and Mr Tait afforded Mrs Drummond a few minutes of their time and again both parties advised that no permission would be given.

Not to be deterred Mrs Drummond attended a surgery held by Mr Fergus Ewing at Grantown in May 2011. At this meeting Mr Ewing agreed to write to Mrs Jane Hope requesting a meeting with the Cairngorm national Park.

We contact the Cromdale Community Council who gave their unanimous backing to our proposed development, a copy of their letter was presented to Mr Ewing and Mr McKee.

On 9 September 2011, Mrs Drummond attended a meeting with Mr Ewing and Mr Don McKee where a lengthy discussion took place regarding the proposed build and it was agreed that Mr Tait would visit the site and give his findings to back up the Park's previous advice that we would not be granted permission to build.

During this meeting Mr McKee asked if we had exhausted all other alternatives ie. Was there no other property for sale in the area which we would wish to buy. Was there no other available plot ie Faebuie which we could buy, etc.

After advising Mr McKee of the reasons behind the sale of our previous house we also advised Mr McKee that given the design of our proposed build no plots, at a price affordable to ourselves, were available. We wished to build an Eco house and had searched for a suitable plot into which our house would blend into the countryside and not be an 'eye sore'.

At the site visit Mr Tait agreed that the proposed build would possibly be acceptable taking into considerations advised by him and also that we should contact Transport Scotland as he believed we would not be able to provide an access to the site.

Mr Andy Donaldson duly attended the site and advised that the current access into Tom An Uird woods would be acceptable and provided information on the alteration to the gradient, etc.

We have lived in this area since 1980 moving from Kincraig, our children have all grown up here and been educated in the Grantown Primary and Grammar schools. We have both worked here in local business since 1974 and 1977 as you can see from our personal history.

We want to remain in this area so that our 14 year old Son can complete his education and hopefully become employed in local industry/business.

Thank you for attending the Community Council Meeting last night to outline the proposal for your Timber Constructed home hoping to be built in Cromdale.





There is no question in my mind that Ann is a valuable member of the local community, and an asset to the Park.


