19. The planning officers noted Members' comments and were delegated with the responsibility of whether or not to submit the comments to the Local Authorities. The following comments were passed on to the Local Authorities.

20. 2012/0367/PPP - Erection of house

At Land 700M East Of Congash Farmhouse, Grantown-On-Spey

The CNPA would highlight that the site lies within an area designated as Ancient Woodland and as such full compliance with Local Plan Policy 3 on Other Important Natural and Earth Heritage Sites and Interests and associated supplementary guidance on Natural Heritage is required. The CNPA suggests that full consideration be paid to any ensuring that, in the event of the application being supported, there is no disturbance to existing trees and vegetation within the area of Ancient Woodland (with full consideration taken of any impacts arising out of any requirements for formation of visibility splays) and that the opportunity is taken to maximise biodiversity and landscaping of the site to ensure any new development sits well in the landscape. Also that full consideration be given to ensuring that the principle of a new house on this site complies fully with the requirements of Local Plan policy 22 for housing outside settlements

 - CNPA recommend that detailed consideration be given to the case for the acceptability of replacing the existing porch, which is specifically mentioned in the detailed description of this category B listed building and described as a good example of a little altered Victorian classical house
