

(partly constructed)




KEY POINTS



Hazardous Substance consent




KEY POINTS


- Site located at Glenlivet Distillery, Ballindalloch;


Proposal: Construction of bedroom wing extension and installation of PV panels

- Proposal not considered to raise issues of general significance




Proposed solar panels to roof




Proposed extension and conversion


KEY POINTS


Proposed sun lounge extension

KEY POINTS :


- Site located in Aviemore;



Proposed solar panels to hall roof




KEY POINTS


- Proposal seeks planning permission for installation of solar panels to roof of community hall – rear roof plane;

KEY POINTS

- Site located by River Dee at Crathie, Braemar;
- Proposal for erection of fishing hut - a new traditional pitched roof hut to the NE of an existing one, with vertical timber cladding and a corrugated profile roof. Open verandah to river side. The existing hut would be retained and used to form a toilet and store;
- The development proposed is not considered to raise issues of general significance to the aims of the National Park
