**Purpose:** To update the Forum on our work in developing Active Cairngorms

### For information

1. There were 42 responses to the public consultation which was held from 12<sup>th</sup> January 2015 to 10<sup>th</sup> April 2015
  - a. Responses were received from members of the public and key stakeholders such as Regional Transport Partnerships, Sustrans, Sport Scotland, Paths for All Partnership, NHS Highland and Local Authorities (**see appendix A**).
  - b. Feedback was broadly positive and supportive of the strategic aims, priorities and policies. Minor text changes will now be made to the main report and the action plan.
2. There were a total of 45 additional consultation approaches and meetings held with stakeholders over the period (**see appendix B**).
3. The final strategy will be emailed to Forum members before being presented to the CNPA Board for adoption on 26<sup>th</sup> June 2015.
