Re Planning Application no. 14/01791/APP Wigwam project at Tomintoul,

I object to this proposed development on the grounds that it will alter the quality of our lives and our enjoyment of living in this house. I know this will be the case, as we already experience some disruption from the so called wild camping that takes place within 150 metres of our home.

However, we are willing to tolerate the amount of wild camping as it is fairly rare, whereas this amount of wigwams is a massive development. Considering the potential numbers using this facility, there is likely to be noise and disturbance to residents on the Main Street from revellers walking home late at night.

It will affect the wildlife as this is the only semi-natural forested area that lies adjacent to the village. It is rich in wildlife partially because of low human activity, and, because of its close proximity to the village, it gets a lower level of management than that which goes with the more common, intense control of wildlife that can take place.

Development on this scale will greatly interfere with the well-being of several species which currently, live within this limited, forested area. It is particularly important habitat for roe deer, red squirrel, pine martin, bats, woodpecker, hedgehogs and many others.

Development in this village has sadly been strangled over many, many years, and so, any ultra- new development needs careful consideration.

This development potentially, could house more than all the rest of the holiday accommodation available, at present, in the village. Anything which has the potential to damage the already fragile, holiday accommodation market, is not what is required.

This area was originally planted for the shelter of the village and should remain so. Since the clear fell of the nearby shelter belt, this is the only wood which lies between the village and the open hill. If this area is taken out, it will leave what little trees are left, vulnerable to wind blow.

It would appear that some existing trees would be retained, but this will not work as these trees have grown in the shelter of a wood and would almost certainly blow over. Even the broadleaf saplings that have survived are very spindly and would be unlikely to be of use.

The area in question lies close to an area where moor burning takes place, and therefore, there is an additional risk of heath fire.

I, therefore, ask that permission for this development be turned down.

Re: Planning Application No. 14/01791/APP Wigwam Project at Tomintoul

We understand that planning permission for WigWam (wooden chalets) is being requested inconjunction with the Crown Estate. We seriously object to this request for the following reasons.

- 1. We or our neighbours have never been approached by either the Council or Crown Estate to ask our opinion re the Wigwams, it seems we are not immediately next to them so it will not affect us, this is not so.
- 2. The effect on the environment, wildlife etc. (for which the Crown Estate say they are very concerned about) will be drastically reduced. We have at present a diverse habitat for plants, insects, birds and animals which include Roe Deer, Red Squirrels, Bats, Owls, Woodpeckers, birds of prey plus many other birds. Opening up the area for development will create serious effects on the balance of the forest habitat, bog and heather moorland, once the area is opened it will effectivly alter and make worse the area for storm and wind damage to any remaining woodland and local human habitat.
- 3. We already have a large variety of accommodation for tourist both in Tomintoul and surrounding areas, who in turn would be effected by this development.
- 4. The high volume of traffic and noise during and after contruction would affect the quality of ours and our neighbours lives. We are already effected by the wild camping area i.e. minibuses, motor homes, groups camping in large tents all arriving in vehicles, groups shouting coming home from the pub and also in the play area. In our opinion wild camping is for backpackers staying for 1 or 2 nights and not in groups for 2 or 3 nights. If the development was accepted this would only make matters worse.

We, therefore, ask the permission for this or any future development of this site be turned down.

On behalf of The Crown Estate, the landowner in this planning application, we would like to express our support for this application.

We have worked in partnership with the applicant, Wigwam Holidays, in order to support their objective to create an area of wigwam lodges within a natural wooded setting, adjacent to the village of Tomintoul.

We strongly believe that this project will add to the regeneration and long term sustainability of the village and surrounding area, and have a beneficial impact on the local economy. It is consistent with the aims of the Cairngorms National Park Local Development Plan and the Tomintoul & Glenlivet Regeneration Strategy, in which it is specifically mentioned as an action point.

Several sites were considered with the developer, including those identified in the local plan for tourism development, but we are in agreement with the developer that the proposed application site is actually the optimum location for the wigwams and will contribute to the sustainable future of the village.
