5. 2012/0055/DET - Installation of hydro electric scheme, powerhouse, access tracks and bridges

At Bruar Hydro Scheme, Pitagowan, Blair Atholl

The decision was to call-in the application for the following reason:

- The proposed development involves the siting of various structures in and around sensitive water courses. It is considered to raise issues of general significance in terms of the natural and cultural heritage, the use of natural resources and the socioeconomic development of the National Park. #### COMMENTING ON APPLICATIONS NOT CALLED-IN BY THE COMMITTEE

- 25. The planning officers noted Members' comments and were delegated with the responsibility of whether or not to submit the comments to the Local Authorities. The following comments were passed on to the Local Authorities.
- 26. 2012/0057/DET To site a portable toilet facility during the summer months (Easter to the Autumn School break), for a period of five years.
  At Old Telephone Exchange, The Brae, Kincraig
  - As a short term measure to resolve the lack of public toilet facilities as identified by the local community in Kincraig, the proposal is welcomed. However, having regard to the highly visible location and the prolonged period that the facility is proposed to be on site annually, it is suggested that it efforts could be made to improve the aesthetics of the facility. In addition, in the longer term, it may be appropriate to consider a more permanent and aesthetically appropriate solution, which would offer an enhancement of visitor facilities in the area and also enhance the visual qualities of the site.
- 27. 2012/0060/DET Erection of Boundary Fence (Retrospective)
  At Old Post Office, Girnoc, Ballater AB35 5SS
  - Having regard to the Listed status of the Old Post Office and the
    first aim of the National Park which includes conserving and
    enhancing the cultural heritage of the area, it is suggested that the
    current boundary treatments are insensitive, inappropriate and
    intrusive in this setting. In addition, it is disappointing that the
    works have been undertaken in an unauthorised manner.
- 28. 2012/0061/LBC Erection of Boundary Fence (Retrospective)
  At Old Post Office, Girnoc, Ballater AB35 5SS
  - Having regard to the Listed status of the Old Post Office and the
    first aim of the National Park which includes conserving and
    enhancing the cultural heritage of the area, it is suggested that the
    current boundary treatments are insensitive, inappropriate and
    intrusive in this setting. In addition, it is disappointing that the
    works have been undertaken in an unauthorised manner.

## 29. 2012/0062/DET - Erection of Shed (Retrospective) At Old Post Office, Girnoc, Ballater AB35 5SS

• The CNPA wish to express disappointment that the works have been undertaken without the benefit of planning permission.

## 30. 2012/0067/NOT - Erection of three polytunnels At Land Im East of Lower 19, Skye of Curr Road, Dulnain Bridge

- Having regard to the type of construction of polytunnels, it is recommended that a maintenance programme is devised and implemented in order to ensure that the structures do no deteriorate over time.
- 31. 2012/0072/DET Demolition of existing sub-standard cottage and erection of new house

At Dornoch Cottage, Nethy Bridge PH25 3DD

- In the event of consideration being given to the granting of planning permission, sufficient evidence should be provided, including details of the structural condition of the existing property, to demonstrate that the proposal accords with CNP Local Plan Policy 23 on Replacement Houses. It is also recommended in the interests of conserving and enhancing the natural heritage of the area that the proposed new dwelling should be sited to ensure that the maximum number of trees can be retained on the site.
- 32. 2012/0074/DET Change of use from Class 4/6 to Class I Barber Room
  At Unit 8, Dalfaber Ind Estate, Dalfaber Drive, Aviemore PH22 IST
  - The CNPA are disappointed at the retrospective nature of this application. In addition, having regard to the fourth aim of the National Park to promote the economic development of the area, it is suggested that the use of premises within an industrial estate for service activities, such as the proposed Barber Room, should be carefully assessed in the context of the need to maintain and protect the vitality and viability of the commercial core of Aviemore village.
