• The proposal is for the retention of a car park for recreation purposes within the Lochnagar and Deeside National Scenic Area. The site is also located within a Special Area of Conservation and in an important area for recreation within the National Park. The proposal raises issues regarding nature conservation, landscape, and issues relating to promoting access and understanding of the special qualities of this part of the Park. Consequently, the proposal is considered to raise issues of general significance for the collective aims of the Cairngorms National Park.

• The site lies outwith the settlement envelope of Dulnain Bridge and within an area designated as Amenity Woodland in the Badenoch and Strathspey Local Plan where the CNPA have previously called-in and determined an application for a single house. The development of a pair of houses and the associated car parking proposals, raises issues relating to potential loss of woodland, natural heritage conservation, community access and amenity, and the principle of housing outwith the settlement envelope on unallocated land. The proposal also raises issues with regard to affordable

housing. Consequently, the proposal is deemed to raise issues of general significance to the collective aims of the National Park.

Consequently, the proposal is considered to raise issues of general significance for the collective aims of the Cairngorms National Park.

REPORT ON CALLED-IN PLANNING APPLICATION FOR ERECTION OF DWELLINGHOUSE (EXTENSION TO TIME LIMIT ON 02/388/OUTBS) AT LAND AT KIRKBEAG, ALVIE ESTATE, KINCRAIG (PAPER 1)

- 36. Neil Stewart presented a paper recommending that the Committee approve the application subject to the conditions stated in the report.
- 37. The Committee discussed the application and the following points were raised:
 - a) The history of the use of the adjacent path.

- b) The issue of general tree protection and retention through appropriate siting.
- c) An amendment was proposed to condition number 3 to read 'Prior to construction, rather than prior to occupation'.
- d) Clarification of the date of expiry of the pervious permission as stated in paragraph 2 of the report.
- 38. The Committee agreed to approve the application subject to the conditions stated in the report with an amendment to condition number 3 to read 'Prior to construction.'

- 39. The issue of the air balloon over Aviemore Highland Resort was raised.
- 40. Members sought clarification from the Planners regarding planning legislation covering advertising by air balloon and what the CNPA could do to make sure the correct legislation had been followed.
- 41. Members expressed some concern over various issues regarding the balloon, including impact on nesting sites and landscape issues.
- 42. Andrew Thin advised the Committee that pre-application letters relating to a proposal which was not as yet the subject of a planning application had been received by the Ballater Office for each member of the Committee; he suggested that the letters be held by the Ballater Office until such time as the application is submitted. This was agreed by members.
- 43. Andrew Thin advised the Committee that Norman Brockie was leaving at the end of the week; the Committee expressed their good wishes and thanks to Norman.
- 44. Don McKee gave a brief update on the Aberdeenshire Local Plan and updated members on the status of the Angus Local Plan.
