I have served notice to Mr. Gallie on 19<sup>th</sup> Nov.

I do not require any extra storage for the bales of hay as they are already stored on thecroft and have the maximum of 8 bales in at any one time and will not be stored on the same land as the shop and container.

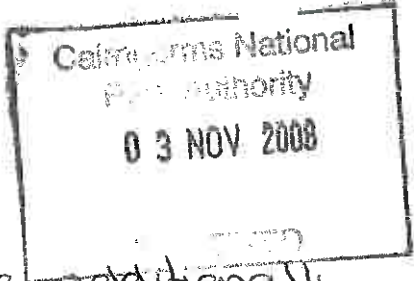
The things that will be stored in the container will be extra stock for the shop such as Horse feed, Showings, Dog & Cat food, and Bird & Poultry food. The shop and storage container will be combined to maximize the flexibility of space.

As for the roof water I have got a 45gallon drum that will be sat at the back for the shop to collect the rain water. This will then be used to water the sheep & hens at thecroft

For the requirement of a toilet I have already considered of putting a portaloos on the land which will be hired from a local company called 'Helen's Portaloos' who is at Boat of Aulden and this company supplies all the hand cleaning, toilet rolls and is all so cleaned every day by them which are included in their service. This will be for the use of both staff & customers.

Further to your letter regarding additionally information the following are the answers to questions that you require for you to approve my planning application.

I have spoken to the land owner and he is in agreement for the alterations to be made to make the entrance access into a bell mouth.

I will be happy to assist on planting some native trees around the bonks if my planning permission goes ahead.

I would expect the amount of customers would be 15-20 per week that will come to my shop. These customers will be coming from the surrounding areas such as - Carr-Bridge, Avenor Methy Bridge, Boat of Garten, Grantown. These customers are currently going into Inverness which is 30 miles from where I'm based to buy their horse feed, accessories and clothing wear to seaforth saddlers and for their dog/pet food and accessories to Pets at Home and also to Kaurm to NDS for the same things and they are 30-35 miles from where I'm based. With having my shop located in the middle of the surrounding areas this will cut down travelling time for the customers and they will also be able to take advantage of my FREE DELIVERY SERVICE which I already provide to the local community

The goods that are and will be sold are as follows

Horses - feed, hay (big round bales), bedding (shavings, paper, straw), herbs & supplements, toys, treats, clothing (saddlery, jackets, shirts), riding boots, riding hats, stable equipment (haynets, feed & water buckets, tie-up rings), grooming kits, rugs, head collar & lead ropes, shampoos, tack, boots & bandages for horses.

Pets - food, treats, toys, leads & collars, beds & bedding, bowls.

Domestic & wild birds - Bird feeders & food

Poultry & farm - feed

All of the products above are what I'm selling at the moment and I have no intentions on selling any other products that is not related to my business.

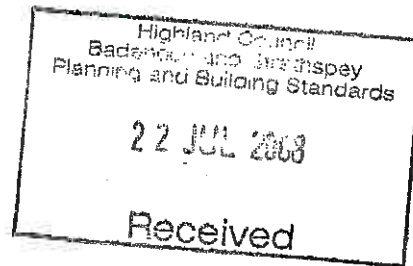

I have been in business for just under six years and the shop that I wish to open at Clury Croft will give me the perfect opportunity to expand my business, and it will all so help to support and strengthen the rural community which will enable them to buy/order their feed in bulk and from a local supplier and get it delivered free.

The bulk feed that I sell out could not be sold through a normal high street outlet as 95% of my orders is anywhere from 4 to 45 bags of feed that go out at any one time and is getting bigger by the month.
