PROPOSED ERECTION OF FLAGPOLES AT THE WESTERN BOUNDARY OF AVIEMORE HIGHLAND RESORT, BY AVIEMORE HIGHLAND RESORT, C/O MACDONALD HOTELS PLC, WHITESIDE HOUSE, BATHGATE, WEST LOTHIAN, EH49 2RX

We represent Scandinavian Village Limited. Further to receipt of neighbour notification on behalf of our client, we write to object to this application on the following grounds:

1. The nature of this application is completely out of character with the amenity of the area;
2. There is potential for noise issues to arise from flags and ropes connecting with the poles; and
3. The application, in part, falls within a Peregrine Falcon protected zone (See enclosed plan).

On the basis of the above points of objection, we would respectfully request that this application be refused. If the Committee are minded to grant planning permission, we would request that the application is amended, to remove the 6 No., 12m high flagpoles located adjacent to Scandinavian Village.
