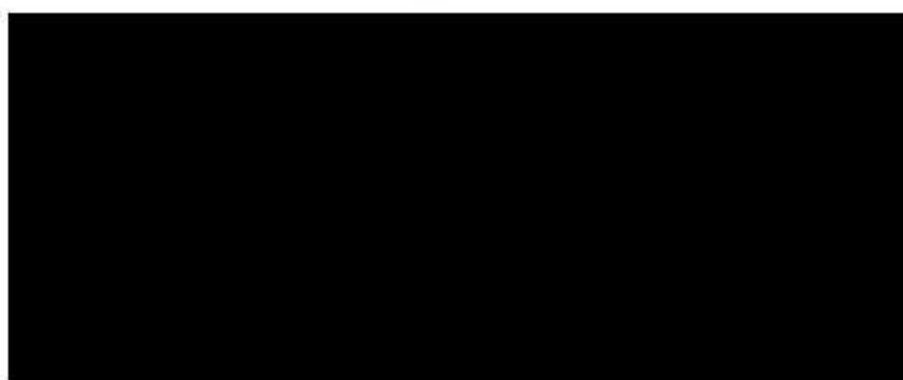

Corgarff Holiday Lodges
