## **Purpose of Report**

To inform the Planning Committee of:

a) A Proposal of Application Notification (PAN)

b) To allow members to raise any views on the issues to be addressed in an application.

#### Recommendation

#### That the Planning Committee:

- a) Note the Proposal of Application Notification for a new non-motorised user route between Aviemore and Carrbridge;
- b) Note the CNPA Officer's advice on the issues to address; and
- c) Make comment on any additional relevant issues to be addressed in any future application.

# **Background**

- 1. The Planning Committee agreed a procedure to allow member involvement in preapplication advice for major planning applications in December 2015. This report informs the Planning Committee of the attached Proposal of Application Notice (PAN). The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was lodged on 15 June to Highland Council. Members are asked to note this may form the basis of a subsequent planning application. The procedure involves officers presenting the information provided with the notification alongside an assessment from officers on the issues that need to be addressed. Planning Committee members have an opportunity to note issues that an application would be expected to address. Members are not being asked to approve the advice of officers.

  - a) Proposal of Application Notice
  - b) Location Plan
  - c) Pre-application response

3. The applicant has carried out a public event, an exhibition on 25 and 26 May and a virtual exhibition which ran from 23 May until 15th June. A further consultation event is required to be undertaken within the next twelve weeks following the submission of the PAN.

## The Proposal

- 4. The proposal is for a new shared use non-motorised user route approximately 10km in length linking Aviemore and Carrbridge.
- 5. The applicant has previously sought the pre-application advice from Highland Council and the CNPA provided advice during that process. A copy of the CNPA's preapplication advice is included as **Appendix 1**.

## **Site Description**

- 6. The route will follow the existing road corridors of the B9152, A95 and B9153. It will start on the eastern side of the B9152 at Dalfaber Drive continuing north where the route will cross the Granish Junction from the eastern side of the B9152 to the west of the A95. The route will then continue along the western side of the A95/B9153 until it reaches Carrbridge. The route will not fall within any statutory designated sites for nature conservation, although there are several within the wider area. The route will be adjacent to and pass through several small parcels of woodland listed on the Ancient Woodland Inventory. An Environmental Impact Assessment will be undertaken.
- 7. A copy of the location plan is attached in **Appendix 1**.
