- 24. The planning officers noted Members' comments and were delegated with the responsibility of whether or not to submit the comments to the Local Authorities. The following comments were passed on to the Local Authorities.
- 25. 2012/0320/PPP Erection of one house

 At Site Adjacent To Milton Farm, Tomintoul, Glenlivet, Moray
 - The CNPA suggests that full consideration be given to the number of existing houses in this grouping in order to establish compliance with current Local Plan Policy.
- 26. 2012/0321/PPP Erection of one dwelling house
 At Plot I, Auchnarrow, Glenlivet, Moray
 - The CNPA suggests that full consideration be given to the relationship to, and number of houses within, the existing grouping to ensure compliance with Local Plan policies for housing in the countryside. The CNPA Board also recommend in the event of the application being supported consideration should be given to style and size of the house and boundary treatments so that it is in keeping with the very traditional style of this small rural grouping.
- 27. 2012/0322/PPP Erection of one house
 At Plot 2, Auchnarrow, Glenlivet, Moray
 - The CNPA suggests that full consideration be given to the relationship to, and number of houses within, the existing grouping to ensure compliance with Local Plan policies for housing in the countryside. The CNPA Board also recommend in the event of the application being supported consideration should be given to style and size of the house and boundary treatments so that it is in keeping with the very traditional style of this small rural grouping.

- 28. 2012/0324/DET Remove (demolish) existing house and erect new house on same site.

 At Inshbreck, Insh, Kingussie, PH21 INU
 - It is recommended in the event of consideration being given to the granting of planning permission care is taken during construction to avoid any environmental damage and to ensure that new landscaping is in keeping with this sensitive location.
- 29. 2012/0326/DET Change of Use from Class 9 (Houses) to Class 7 (Hotels and Hostels)
 At Ivy Cottage, Cluniebank Road, Braemar, AB35 5ZP
 - The CNPA recommend that care be taken with the choice of materials for the car parking area to reflect the location of the site within the Conservation Area, in order to conserve and enhance the cultural heritage of this area.
- 30. 2012/0330/DET Conversion and extension of an existing farm building into one residential dwelling.

At Building 80M North Of Clachaig Cottage, Nethy Bridge

- The CNPA recommend that (if the application is supported) in the interests of maintaining a record of buildings which contribute towards the cultural heritage of the area, a full photographic survey (of the exterior and interior of the building) be undertaken prior to the commencement of any development.
- 31. 2012/0331/DET Sub-divide garden ground and erect new house and associated works.

 At Keepers Cottage, Dalnavert, Feshiebridge, Kingussie, PH21 INQ
 - The CNPA recommend that careful consideration be given to the relationship of the proposed house to the prevailing development pattern, density and levels of privacy and amenity at Dalnavert, given the narrow nature of the site. It is also recommended that care is taken to ensure that the design, scale and finishes are appropriate, with particular attention paid to the unbalanced effect of a single dormer on the front elevation

32. 2012/0333/DET - Erect an agricultural style shed for the storage of machinery, equipment and materials

At Yard Adjacent To Railway Station

Carrbridge

- The CNPA recommend that as part of the consideration of this proposal information is sought on whether other sites on designated land in the village have been considered, in order to demonstrate compliance with planning policy on business development.
- 33. 2012/0334/DET Demolition of Existing Dwellinghouse, Erection of Replacement Dwellinghouse, Domestic Garage and Installation of an Air Source Heat Pump

At Tigh Na Rosan, Tullich, Ballater AB35 5SB

- The CNPA recommend that during construction all efforts are made to retain and protect existing trees in the interests of conserving and enhancing the biodiversity of this site. Also that consideration be given to ensuring the design of the garage reflects the design principles of the house, potentially by use of timber cladding, in order to achieve high design standards.
- 34. 2012/0335/PPP Erect 2no bungalows with detached garages At Plot 6 Cults Drive, Tomintoul, Moray
 - The CNPA recommend that, in the event of the application being supported, due consideration be given in the wording of any conditions to ensure that the layout of any subsequent applications reflects the prevailing development pattern in the area and that the type of boundary enclosures helps to reinforce the original character of the village.
