
KEY POINTS

• Proposal for an amended house type. Planning permission was granted in 2008 for the demolition of the existing steading and erection of house;

• Site in Braemar Conservation Area, adjacent listed building but replacement of steading already accepted. This application changes the materials proposed from granite to timber larch cladding and aluminium roofing to slate. This is not considered to raise issues of significance.

Full Planning Permission Alterations and Extension to dwellinghouse and fence






•Proposal for rear extension to existing house, partly on site of small extension;

•Proposal for garage to side of existing house;


•Materials to match existing;

•The proposal is for a domestic addition to an existing house raising no issues of significance



•Materials include slate roof, natural stone, render and vertical larch cladding;


•Application for replacement house raises no issues of principle or design and is not of general significance to the National Park aims.

Full Planning Permission Alterations and raising roof to form accommodation




Proposal for alteration to existing dwellinghouse including raising roof ridge height;

Full Planning Permission Extend existing balcony




Proposal to extend existing balcony to commercial building;Minor domestic alteration and raises no issues of general significance
