Purpose of Report

To ask the Planning Committee to approve the Local Development Plan Action Programme Review 2019.

Recommendation

That the Planning Committee approve the Local Development Plan Action Programme Review 2019.

Background

- I. All planning authorities are required to publish an Action Programme to set out how the policies and proposals within their Local Development Plan (LDP) will be implemented. Action Programmes are required to include a list of actions required to deliver each of the policies and proposals contained in the LDP, details of who will carry out the actions, and the likely timescales for undertaking the actions. Action Programmes must be updated and republished at least every two years.
- 2. The Cairngorms National Park LDP was adopted in March 2015, and an Action Programme was subsequently published in June 2015. CNPA have committed to publishing Action Programme updates annually and therefore a first year interim review was published in 2016 followed by a full review in 2017. This full review provides a further update on delivery of the LDP.
- 3. This Action Programme Review provides up-to-date information about the delivery of sites and policies within the LDP. These updates are all set out in the proposed Action Programme Review 2019 which is attached at Appendix 1.

Action Programme Delivery Priorities

4. The 2017 Action Programme Review identified a series of delivery priorities for 2018/19 against which CNPA was listed as the lead agency. Progress against these priorities is outlined in Table 1.

		 153,782 impressions across the 3 networks (Facebook, Twitter, Instagram). The videos received 30,169 views across all 4 networks (includes YouTube). Our posts were engaged with (liked, clicked, shared) 10,067 times – resulting in an overall engagement rate of 7% for nonvideo based posts. Engagement with all campaign content, include video, resulted in an engagement rate of 26%. Our campaign content was shared 189 times on Facebook and Twitter and we received 64 comments. 		
		Although it is not possible to quantify the benefits of this in terms of formal responses to the proposed LDP, it is contributing to better informed individuals and audiences.

- 6. In addition, Section 7 outlines progress in delivering the sites that are allocated for development within the LDP. It was updated in 2018 to present information on a settlement basis for clarity, thus providing information for likely infrastructure requirements and all housing, existing permissions, economic development, tourism and community sites together with a settlement map.
- 7. This review provides progress updates on all allocated sites within the LDP, including details of recent planning permissions. Last year it was identified that more advice on developer obligations was required to provide clarity to officers and developers about where developer obligations will / will not be required. The likely obligations required are set out under the 'Anticipated Infrastructure & Affordable Housing Requirements' heading within each settlement and these have also been updated to reflect the most recent school roll forecasts which have resulted in some changes.

Next Steps

8. The Action Programme Review 2019 will be published on the CNPA website. Copies will also be sent to Scottish Ministers and placed in local libraries. The Planning Committee will receive a further progress report and Action Programme Review in June 2020.
