 - The proposal represents the erection of a new dwelling house in a countryside area where there are general restrictions on residential development unless there is a demonstrable justification. The site lies within an Area of Landscape Significance and also within the River Dee Special Area of Conservation. Access to the site also crosses the former railway line which is a proposed core path. The proposal therefore generates considerations in relation to the principle of housing in countryside areas, the precedent for other similar developments, the cumulative visual and landscape impacts of single houses throughout the countryside in the national park, as well as raising natural and cultural heritage issues and access and recreation issues. As such the proposal raises issues of general significance to the collective aims of the National Park.
