1.0 Overview

1.1 This statement sets out the Cairngorms National Park Authority response to the objection raised to the Deposit Local Plan as modified in respect of general layout with regard to the 4 aims of the National park and supplements the response made to those objections by the Cairngorms National Park Authority in its report to Committee (CD7.3-7.5). No changes are proposed.

2.0 Provision of the Local Plan:

2.1 The 1st and 2nd modifications to the Deposit Local Plan made various revisions to the text and format to clarify terminology, the context of the Local Plan and its relationship with other documents, and to expand on the rationale behind various policies. The map showing the location of the National Park is now on the first page of the introduction next to the 4 aims.

3.0 Summary of objection(s)

- 3.1 I objections raising I issue has been lodged on the general issue of layout with regard to the 4 aims and wishes to be considered via written procedure:
 - Everything revolves around the 4 aims and I think they should be set out rather more clearly right at the beginning on the same page as the map. I know they are on page 3, but also need to have them up front where no one will miss them. (017g)
