With reference to planning application 2020/021/DET, Erection of 18 Hut, 4 Compost Toilets and Associated Access, Car Parking and Landscaping

Following discussion of this planning application at our recent Community Council meeting, prompted by members of the community attending the meeting and by correspondence received, the Community Council would like to communicate that whilst it supports developments of this type in principle, this is not an appropriate location for such a development, for two main reasons:

**Road Safety** – Potential for accidents due to increased numbers of vehicles accessing a difficult entrance in an non reduced speed limit area from the A93. In addition, the lack of footpath along the A93 from access to café etc in Crathie could put increased no. of pedestrians at risk. If plans are approved a 30mph limit should be installed.

**Location in an SSSI** – Concern regarding impact on SSSI; risk that hut users take wood from nearby trees for fire wood, potential for wild fires to spread. Concerns regarding the impact of litter & human waste on the SSSI. How will this be managed?

In addition, the number of huts is over development and we have received concerns regarding the removal of existing caravans and their present owners/tenants.

We are also concerned about the lack of public consultation that has occurred and suggest that the applicant revisit the plans after public consultation with the community in Crathie.
