### 2. What is your comment on this section of the Plan?

Disappointed that no site is allocated for allotments. CNPA is giving us mixed messages. A representation made at the time of the planning applications for development of housing site H1 was rejected by CNPA case officer on the basis that allotments were not an infrastructure requirement which had been identified through the LDP process. Now when we seek to have them identified through the LDP process the new LDP's site assessment report into sites suggested for allotments asserts that such sites should be identified via a planning application! Surely the whole point of the LDP process is to identify sites in advance so as to give the community as much certainty as possible about what is likely to happen, and have the chance to comment as early as possible – NOT to let things emerge out of nowhere in the form of ad hoc planning applications?

3. Please state clearly what change/s you wish to see made to the Plan to address your comment

Recognition of the site which has been granted planning permission, both within the town map and in the broader context of revision/ clarification of paras 4.158 and the developer contributions schedule.

#### 2. What is your comment on this section of the Plan?

Para. 4.158 of the draft LDP states that developer contributions may be sought to create or enhance community facilities where a shortfall has been identified, but that contributions would only be sought where (a) this (a shortfall) is the case and (b) there is an established project to create a community facility. On (a), there is an established waiting list held by both the Willow Tree Allotments Association (WTAA) and the Highland Council. On (b), as well as constituting itself formally the Allotments Association has secured planning permission for the development of allotments on a site in the town, with agreements to lease the land from the landowner and a programme of applications for development funding. It is therefore beyond dispute that both tests of para. 4.158 are satisfied. However the proposals map's failure to recognise the site for which planning permission has been granted, together with the ambiguities in wording between para. 4.158 and the developer obligations schedule on page 110, make it significantly less likely that developer contributions would be sought towards creation or enhancement of allotments as a community facility. The developer obligations schedule only refers to "increasing capacity at strategic community leisure facilities serving Grantown on Spey" leaving it open to developers to avoid contributing to the establishment of an allotments site, either by arguing that it is not a "strategic" facility or arguing that if a site is not already in operation there is no capacity to "increase", or both. This is particularly reprehensible given that the site which has planning permission (and only awaits funding for its development) is located between sites H2 and C1, either or both of which could easily accommodate one or more contiguous "increases in capacity" to meet future additional demand.

# 3. Please state clearly what change/s you wish to see made to the Plan to address your comment

The wording of the developer obligations schedule should refer to "establishing or" increasing capacity at community leisure facilities and in order to put disputes about what strategic means beyond doubt should specify that "these strategic community leisure facilities will include allotments (existing or with planning permission)".
