### INTRODUCTION

We understand our role in this is to work with and support the authority in accordance with the Act. To achieve the ambition for National Parks in Scotland enacted in the National Parks (Scotland) Act 2000, (from hereon the Act).

We understand that the general purpose of a Park Authority in the Act is to ensure that the four National Park Aims are collectively achieved in a coordinated way and would like to play our part in helping to improve the way this works.

We trust that our comments and objections will be of help. If not we would like to follow up with discussion.

### Rothiemurchus management

Our aims are aligned with the four aims of the Cairngorms National Park. This comment on the Local Development Plan (LDP) is on behalf of Rothiemurchus Estate. The aims and general purpose of our business are aligned with the four aims of a National Park and the general purpose of a National Park Authority set out in the National Parks (Scotland) Act 2000; collectively delivering all four aims in a co-ordinated way across our land holding.

### Team expertise in biodiversity enhancement

The Rothiemurchus team has considerable expertise in biodiversity enhancement. The enhancement of biodiversity in accordance with policy for SSSIs and Natura 2000 Areas is delivered in conjunction with moorland, farmland and forest plans which have been agreed with the relevant Authorities.

### Enabling Sustainable Access; average of 1,000 visits per day

Rothiemurchus Forest has attracted visitors for over 200 years and has had over 350,000 visits per year for several decades – Scottish Natural Heritage (SNH) have advised us that Rothiemurchus is the most visited protected area in Scotland. Enabling sustainable access in accordance with the Scottish Outdoor Access Code (SOAC), requires over 50 + directly employed staff, 30+ in our Rothiemurchus partner, specialist outdoor activity businesses together with support from residents and our visitors. All our plans and actions must deliver sustainable environmental, social and economic long-term improvement and enrichment of the natural and cultural heritage.

### Nature and People together

For Aviemore and the other Badenoch and Strathspey communities, we deliver sustainable enhancement of biodiversity together with enabling significant numbers of residents, businesses and their customers to enjoy sensitive habitats and wildlife. For example, Rothiemurchus is well known for management of habitat which has enabled Osprey and Capercaillie to raise enough chicks to repopulate neighbouring areas or be translocated; we are also well known for the large numbers of people who are welcomed to sustainably enjoy a wide choice of outdoor activities which do not disturb sensitive wildlife or habitat.

### Housing issues are a significant constraint on delivery of all the aims of the Cairngorms National Park.

Relevant to this LDP are the challenges we have recruiting and retaining staff who want to have a career here and buy a home which is suitable for their evolving needs. Some do, but many can't stay here and move on to cities and other places where it is easier for them to find a home and a housing ladder. The management time that is spent on staff housing related issues is a significant constraint on the business and is a disincentive to investment. During the summer of 2018 we had to reduce the services we offered because staff who could not drive had problems with finding accommodation. Visitor expectations could not be delivered because a successful business in Aviemore had to close on busy days due to the shortage of suitable staff and we could not accommodate their disappointed customers.

### Staff Motivation, a fair opportunity to have a good quality of life

Our biodiversity is exceptional, and we need people who live here and visit to feel special and be motivated to care for the Cairngorms National Park (CNP) and enjoy it sustainably. The best way of achieving that outcome is to ensure that our staff have a fair opportunity to have a good quality of life here – if they feel they are less important to the CNP than visitors and the natural heritage they care for, they will not be well motivated to ensure that what we do and how we do it meets international expectations of a National Park or feel like being part of delivering the Park Partnership Plan.

Objection

1.11 Long Term Designations:

Every effort should be made by Cairngorms National Park Authority (CNPA) and its partners to deliver An Camas Mòr as originally envisaged in the CNPA Local Plan and according to the CNPA Principles for An Camas Mòr (paper 3, 12 December 2008) without further delay.

The proposal that Aviemore's long term growth should be in a carefully planned sustainable sister community across the River Spey, rather than continue urban sprawl confined by the old and new A9, two railway lines and the river Spey, was first introduced by Aviemore and Vicinity Community Council (AVCC) and came as a shock to the family owners of Rothiemurchus. It is AVCC and The Highland Council's continued support for An Camas Mòr, together with CNPA and Highlands and Islands Enterprise which motivated Rothiemurchus owners not only to support the communities but invest £2 million in the process of applying for planning permission to build a sustainable community which can become a world class exemplar. We recognise its critical contribution to the life chances of people living locally as well as collectively delivering all four Aims of the CNP in the most designated and visited part of the Cairngorms.

The Park Partnership Plan and the Cairngorms Economic strategy seek diversification of the economy away from lower paid occupations to a more balanced community. Our plans, after repayment of infrastructure and planning costs are to invest in homes for residents, starter business premises to rent and the heritage to help ensure the long-term sustainability of the village in its setting.

The long-term designations LTH1 and LTH2 do not replace the immediate need for An Camas Mòr because, in contrast to Aviemore, only An Camas Mòr can meet environmental, community and visitor needs as follows: -

1. It is the vision of the Aviemore and Vicinity Community Council for a carefully planned sustainable sister community across the River Spey including community facilities and carefully planned recreation facilities with a countryside park, playing fields, other leisure space and links through to the Core Path networks leading to the Cairngorms.
2. Is in the right place: it is where visitors want to be, and it is where there is the greatest demand for services and so employment. Aviemore, Rothiemurchus and Glenmore are the most popular destination in the Cairngorms and the most popular all the year-round destination in the Highlands. Rothiemurchus and Glenmore are well known for sustainable management of the natural and cultural heritage and for enabling sustainable public enjoyment. Rothiemurchus and Glenmore has a long tradition of coordinated management resulting in exceptional natural and cultural heritage. SNH monitor the sites designated under European legislation and within Rothiemurchus they have consistently achieved Favourable Condition as well as accommodating an average of over 1,000 visits a day to its forests.
3. An Camas Mòr Plans recognise the need for sustainable and resilient communities taking responsibility for their role in looking after the natural and cultural heritage and the people who come to enjoy it.
4. It has been designed with people living locally working together with world renowned professional and specialists who have listened carefully to people living and working in the area and so it prioritises the needs and aspirations for those who live and work here.
5. It is phased to meet accommodation requirements for those needed to look after the CNP and those who visit it and to provide for a balanced community with diversified employment opportunities.
6. It plans for sustainable development including a full range of public facilities, recreation, work space, child care and fair opportunities for people working locally to buy or rent a home.
7. The Park Partnership Plan and the Cairngorms Economic Strategy seek diversification of the economy away from lower paid occupations dependent on visitors to the CNP, to a more balanced community.
8. The plans depend upon fair opportunities for people who live and work nearby to rent or buy a home designed for their needs.
9. Together with Aviemore, it has the scale to justify the public services that are needed within the two communities; it also has the scale to be attractive to the Council and Housing Trusts to provide affordable homes.
10. It has plans to reduce the proportion of vacant houses by favouring full time occupation.
11. The site has been safeguarded and managed 'gardened' for over twenty years so that people can live close to and appreciate nature and most wildlife can live within, pass through and over it and when complete the village can fit in the landscape, mainly screened by trees.
12. Other land has been identified and can be safeguarded for moorland, wetland and forest enhancement.
13. It can change the perception of the area. For the last 50 years Aviemore has grown steadily northwards by piecemeal development in response to crisis; it is constrained by the old A9, the new A9 and two railway lines; and so demonstrates all the issues resulting from urban sprawl development.
14. A full environmental assessment has been carried out and the CNPA MINUTES OF THE PLANNING COMMITTEE held at Glenmore Lodge, Aviemore on 23rd August 2013 at 11.00am.

4.19, 4.20 and 4.21; There has been much progress in the delivery of affordable housing during the period of the current and previous plans. However, this has not addressed the lack of supply of the right type of housing for people who either do not want or do not qualify for affordable homes. Furthermore, there is apparently no attempt by the Park Authority to collect evidence of the level of need for these homes or the monitoring of their provision on a travel to work area basis. Whilst 4.21 gives some recognition to the problem there is no apparent solution taken forward into policy. This issue is holding back business and our ability to maintain confident staff in pursuing the aims of the Park.

Rothiemurchus estate employs a staff of over 50 looking after the heritage and those who come to enjoy it. Considerable management time is taken up helping staff address accommodation issues and replacing people who have had to leave to find a suitable home. We are therefore familiar with the housing crisis in the area.

This section 4.14 addresses some housing issues but makes no allowance for the significant proportion of people who are not attracted to place their names on the housing list. Currently many of them move away to work in places where they can afford to buy a home; they go uncounted. These are also the people who would diversify the economy away from the reputedly lower paid sectors into technical and learning occupations as recommended in the Cairngorms Economic Strategy and the Park Partnership Plan. Evidence for that is provided by the Highland Small Communities Housing Trust An Camas Mòr Detailed Report for An Camas Mòr LLP investigating provision of homes affordable for people that live and work locally, including tenure and bedroom number preference, November 2017.
